4.	Course content	
1.	Brief description of the course and its content including details of any sub-divisions	<p><i>The course focuses on the possible and actual roles of rhetoric in present-day liberal democracies from the perspective of civic participation in politics.</i></p> <p><i>Students are provided with general knowledge of the links between rhetoric, democracy and participation and how they can be understood from theoretical and practical perspectives. Special emphasis is placed on the conditions of persuasive discourse in relation to rhetorical theory.</i></p> <p><i>Informed by current research, the course addresses the possibilities of rhetoric to constructively contribute to the development of democracy, taking into account the discourse situation and adaptation to the audience, register and style, form and content, source criticism and the significance of the presentation. Other topics addressed include relational conditions, the role of the receiver and the significance of listening, and the ability to provide feedback and constructive criticism.</i></p> <p><i>Through presentations, dialogues and discussions, the course will query rhetorical issues and perspectives related to the responsibility of the rhetorician for the conditions and outcomes of the communicative situation.</i></p>

1.	Teaching methods employed including details of any compulsory components	<i>In addition to lectures and workshops, the course includes student/project presentations. Attendance is compulsory at workshops and student presentations.</i>
2.	Examination details	<i>The assessment is continuous and based on active participation in seminars and workshops, a project presentation and a written paper. Absence at more than two seminars must be compensated for with written assignments in accordance with the instructions of the lecturer.</i>
